AS THE FOSTER, I AGREE TO THE FOLLOWING PROVISIONS:

1. I agree to keep an identification tag attached to a properly fitted collar that will remain on the Fostered Animal at all times, inside or outside of the house, and to obtain all city licenses required by local authorities.
2. I agree to provide the Foster Animal with necessary inoculations at the intervals advised by my veterinarian.
3. I agree to have the Fostered Animal under my control when he/she is not within the confines of my property. A secure fenced area will be provided for dogs, including shelter from the elements. If the Fostered Animal is a cat, I agree to keep the cat as an indoor-only pet. The Fostered Animal will not be tied or chained.
4. If for any reason I cannot keep the Fostered Animal for the time needed, I agree to notify The White Kitty Foundation of the need for another foster family for the animal and to return the animal upon request.
5. I agree not to abuse or neglect the Fostered Animal and I authorize the Foundation, at his/her sole discretion, to determine whether or not the pet has been abused or neglected.
6. I understand that any failure to perform the foregoing agreement will constitute a breach of contract. In the event of any such breach of contract, I authorize The White Kitty Foundation to reclaim both possession and ownership of the Fostered Animal.
7. I agree to give The White Kitty Foundation visitation rights to ensure that the terms of this Foster agreement are being observed.
8. I understand that I will be handling animals while providing my volunteer services for the White Kitty Foundation (WKF) and therefore there exists a risk for personal injury. On behalf of myself, my heirs, personal representatives, and executor, I release, discharge and hold harmless the WKF its agents, servants and employees from any and all claims, causes of action or demands of any nature or cause connected with my volunteer contract. Such damages are not limited to but may include animal bites, accidents, injuries and personal property damage.

I HAVE READ AND FULLY UNDERSTAND THE TERMS AND CONDITIONS OF THIS VOLUNTEER AGREEMENT AND I WILLINGLY COMPLY WITH ALL OF ITS CONDITIONS.
